The Aiut Group strives to uphold the highest standards of business conduct and is committed to the continuous implementation of best practices. The Aiut Group consists of the parent company and all its affiliated subsidiaries.

The parent company is Aiut sp. z o.o., headquartered in Poland. Affiliated subsidiaries are defined as any entities directly or indirectly controlled by Aiut sp. z o.o. "Controlled" is understood as holding at least 50% of the shares, stock, or majority voting rights.

As defined in this Aiut Supplier Code of Conduct, a Supplier is a person, organization or company that supplies, sells or leases materials, products or services directly to the AIUT Group.



The Aiut Supplier Code of Conduct is guided by the fundamental principles outlined by the United Nations in the Guiding Principles on Business and Human Rights and emphasizes our commitment to respect all human rights recognized worldwide in accordance with the International Labor Organization's Declaration on Fundamental Principles and Rights at Work.

We have created a Supplier Code of Conduct to outline our expectations regarding the business practices of our suppliers and to ensure that they are also guided by these principles.

The Aiut Supplier Code of Conduct describes minimum requirements for Suppliers on acting in accordance with the values and principles of social responsibility and sustainability development. Social responsibility and sustainability are important elements of the company's strategy.

The AIUT Group conducts business in accordance with the highest ethical standards, guided by an elaborate value system based on respect, integrity, responsibility, solidarity and cooperation. Our Supplier Code of Conduct sets out the minimum, non-negotiable standards that shall be met by all Suppliers in our supply chains in accordance with the with the due diligence rules described in this document.

Ethical requirements include:

- Business integrity
- Privacy and intellectual property
- Ability to report violations of the law

Data Protection:

The Aiut Group attaches great importance to the security of personal data processed in connection with its operations. Accordingly, it works only with entities that guarantee the provision of adequate security of personal data.



PRINCIPLES OF ETHICAL CONDUCT



Fair

competition

Suppliers act in respect of fair competition, regulations regarding antimoney laundering, monitor and prevent conflicts of interests. They promote attitudes ethical among employees and business partners.

Anti-Corruption

Any form of corruptive behaviour is unacceptable. Suppliers have an absolute obligation to comply with anticorruption applicable laws, taking into account local and international regulations.



Suppliers owe a duty to keep information confidential.

"Confidential Information" often referred to as business secrets, is any information that has commercial value to the Aiut Group. The above definition includes inventions, business secrets, and commercial information, technical information, computer programs,

product designs and manufacturing expertise.

The Aiut Group information that is publicly available, do not constitute Confidential Information. The Aiut Group Suppliers should maintain strict confidentiality of information used or obtained in the course of their duties.

information documents All and from previous, current future or should projects be treated the client as property of the adequately protected from and unauthorized access. Disclosure of any confidential information is prohibited. The Aiut Group Suppliers guarantee the highest security of information stored in their databases and systems.

The Aiut Group expects that before an execution of any photos, videos, advertisements of Aiut's production facilities belonging processes or to the AIUT Group, Suppliers and their employees should ask for written approvals from the AIUT Group. Before issuing any public statement press release of commercial or material with AIUT's name, logo or trademarks, suppliers must also ask for a written approval from the AIUT Group.



HUMAN AND LABOUR RIGHTS

We request Aiut Suppliers and Business Partners to respect the human and fundamental rights of the countries in which they operate and to ensure a fair working environment. In addition, we expect them to combat violations of rights, discrimination and adverse conditions as part of human rights due diligence. This area includes, among other issues:


WE INNOVATE TECHNOLOGY

HONESTY AND TRANSPARENCY

In its business practice, the Aiut Group acts in accordance with the key values contained in the Code of Ethics, setting forth expected attitudes and behaviours within professionalism and credibility, placing importance on cooperation, safety and social responsibility.

The company is committed to the concept of responsible business taking care of the credibility and transparency, builds lasting and transparent relationships with stakeholders. Suppliers agree to comply with all applicable laws, contracts and generally recognized norms and standards.

Suppliers are requested to comply with all applicable laws, both national and international agreements, contracts, generally applicable standards and industry codes. Suppliers are also requested to communicate this Code to their employees and subcontractors and ensure that they are aware its contents.

Aiut provides comprehensive support to its suppliers to build awareness of good practices and responsible business, offering training, consultation and access to specialists, recognizing this as the foundation for sustainable development and ethical cooperation based on mutual trust.

The Aiut Group reserves the right to review awareness of the Aiut Supplier Code of Conduct at Suppliers and Business Partners through appropriate actions. This may, for example, take a form of questionnaire, self-assessment or audit of suppliers at their premises. Audits at plants will be announced in advance and conducted along with suppliers' and business partners' representatives in accordance with applicable laws, including data protection regulations. Suppliers and business partners shall present openly information required for audits and evaluations.
